The vendor is required to follow the instructions listed in this routing guide. Not following this guide, such as using unapproved carriers, not completing bill of lading as directed (include PO numbers) can result in the vendor being billed for the freight charges and/or a negative impact on invoice payment for the provided material.

SHIPMENTS BY GROUND WEIGHING 70 LBS. OR LESS: SHIP UPS COLLECT

SHIPMENTS BY GROUND WEIGHING MORE THAN 70 LBS:

Técnico's standard terms are FOB Shipping Point, Freight Collect for less-than-truckload (LTL) shipments.

Utilizing the by-state carrier guide, choose the preferred carriers listed by the state from which the vendor is shipping.

Example: 350 lbs. shipment from National City, California to Técnico's Chesapeake facility, use YRC, Old Dominion or ABF, FOB Shipping Point, Freight Collect.

Attached are examples that show how to fill out truck Bill of Lading. Técnico's PO number must be used on all documentation.

- If the purchase order freight terms are *freight collect*, the **shipper** must not prepay and add to the material invoice.



- If the **vendor** prepaid and added freight to the material invoice, Técnico requires that a copy of the paid freight bill accompany the material invoice. Freight collect is the preferred method – this enables Técnico to utilize negotiated freight discounts with preferred carriers. The buyer will be notified if the vendor is not able to ship collect.

- **DO NOT SHIP C.O.D.**

SHIPMENTS BY AIR, FLATBEDS, EXCLUSIVE USE, RAIL, OCEAN, OR BARGE

Small air shipments weighing 70 lbs or less	Ship UPS or FedEx collect
Air shipments over 70 lbs	The transportation logistics coordinator or an authorized Técnico representative will coordinate
Shipments by flatbed or exclusive use	Contact Técnico’s transportation logistics coordinator
Shipments by rail, ocean, and barge	Contact Técnico’s transportation logistics coordinator

MANDATORY REQUIREMENTS

Técnico’s Material Purchase Order number must be included on all Bills of Lading.

Purchase order numbers must be a Técnico Material Purchase Order number, not the suppliers’ third party number.

RECEIVING REQUIREMENTS FOR MATERIAL SHIPPED TO TÉCNICO CORPORATION

The following are requirements for material deliveries to Técnico from suppliers. Suppliers must meet these requirements, or a delay in payment may occur.

1. Each shipment must include a legible packing list for each PO line item number of each material purchase order.

2. Two (2) copies of the packing list shall be provided, one attached to the outside of the material (box, crate, container, etc.) and the other inside the container.

3. Each packing list and each box shall contain:



- a. Técnico's material PO number
- b. Total number of marked containers associated with packing list
- c. The unit of measure for the item number
